

ASENIWUCHE WINEWAK NATION CITZENSHIP APPLICATION FORM – RELATIONAL MEMBER

As prescribed by the Membership Committee in accordance with the Aseniwuche Winewak Citizenship Code

This application form is for individuals not eligible as AWN Traditional Members but who meet the Relational Member criteria under s. 9 of the Citizenship Code. A Relational Member is someone welcomed into the Aseniwuche Winewak community through: (a) marriage or common-law relationship with a Traditional Member, including minor stepchildren; (b) custom adult adoption by a Traditional Member; (c) maintaining kinship despite dissolution of a marriage or common-law relationship, including minor stepchildren; or (d) being a stepchild of a Traditional Member, now over 18, maintaining a kinship tie. Refer to the Citizenship Code for full information.

Notice regarding personal information: The information below is being collected for the purposes of establishing citizenship in the Aseniwuche Winewak Nation, and, if citizenship is established, for including a citizen on the Enrolment Register. The Enrolment Register may be used to communicate information internally within Aseniwuche Winewak Nation and externally to other governments (e.g. Canada, Alberta) about Aseniwuche Winewak Nation citizenship, such as to identify citizens for the purposes of exercising s. 35 rights, or to establish eligibility for programs, services, and benefits. Such information may include, but is not limited to, names, birth dates, mailing address, and category of citizenship. If you have questions about the collection of information, please contact the Membership Clerk.

Warning: Any false or misleading statement with respect to this application or supporting documents, including the concealment of any material fact or circumstance, may result in the removal from the Enrolment Register under Part 5 of the Citizenship Code.
